Thomas County is hosting a shooting sports local state qualifier match for BB Gun. All levels of shooters are invited to participate from 4-H age 8-15. 8-year-olds are welcome to participate but will not be eligible to participate at the State Match.

**NOTE: the minimum age to participate at the State Match is 9 years old before Jan. 1, 2026.**

Registration form and fees are due by end of day Friday, February 27, 2026. Mail to Thomas County Extension Office, 350 S. Range Ave., Suite 16, Colby, KS 67701 or email to [tfagan@ksu.edu](mailto:tfagan@ksu.edu). Late registration will only be accepted to fill relays. Check in and relay times will be sent to coordinators depending on number of shooters. We will only accept registration from one person per county and this person will be notified of relay times.

**Registration begins at 8 AM**, each county needs to verify their shooters information when checking in for correct age.

**Fees are \$15 per shooter. \*\*\* No concessions will be available. \*\*\***

**Jr. & Sr. Age Brackets will be determined after all registrations are turned in.**

Jr. 8-11 years old. Sr. 12-15 years old.

Match will be conducted following state match rules.

**BB Gun:** Shooters will shoot 10 bull shots in each of the 4 positions. Rules will follow the current NRA BB Gun Rulebook. Individual Awards for BB Gun will be given to the top 5 shooters in Junior and Senior divisions. To qualify for the State Match in BB Gun, the minimum individual score is **335**. Everyone will shoot as an individual with the top 4 shooters from each county making up the team. Team awards will be given to the top 3 teams overall.
